# **Compliance Status**

#### **Non-accessible Content**

The content listed below is not accessible for the following reasons: non-compliance with Law No. 4 of January 9, 2004

- **1.4.3 Contrast (Minimum)**: In some sections, the contrast between the text and background may not meet the recommended minimum levels, making it difficult for some users to read.
- **2.1.1 Keyboard:** Some functions are not operable via keyboard (or similar input interface).
- **2.4.7 Focus Visible:** Some interactive elements do not show a visible focus indicator.
- **2.4.3 Focus Order:** On some web pages where navigation order affects meaning or functionality, focusable elements may not follow a logical sequence.
- **1.3.1 Info and Relationships**: In some sections, information, structure, and relationships conveyed through presentation may not be programmatically determined or available in text for assistive technologies.
- **2.4.1 Bypass Blocks**: There is currently no mechanism to skip repeated blocks of content like navigation menus or headers.
- **2.4.6 Headings and Labels**: In some cases, headings and/or labels do not sufficiently describe the purpose or function of elements.

- **4.1.2 Name, Role, Value:** Some user interface components (e.g., form elements, links, script-generated components) lack proper name, role, states, properties, or values, or changes are not communicated to assistive technologies.
- 2.4.4 Link Purpose (In Context): The purpose of some links may not be determined from the link text alone or its context.
- **2.5.3 Label in Name**: Some visual labels are not included in the accessible name, making it harder for voice-based assistive technology users to understand.
- **3.3.2 Labels or Instructions**: In some cases, labels or instructions are missing when user input is required.
- **2.2.2 Pause, Stop, Hide**: Certain automatically triggered animations, blinking, scrolling, or updating information lasting more than 5 seconds lack a mechanism to pause, stop, or hide them.
- **3.3.1 Error Identification**: Input errors may not always be clearly indicated and described to the user.
- **3.3.3 Error Suggestions:** When input errors are identified and correction suggestions are known, they are not always provided to the user unless this would compromise the content's security or purpose.
- **1.1.1 Non-text Content:** Some non-text content lacks an equivalent text alternative serving the same purpose.
- **1.4.5 Images of Text:** Alternative text is not always provided or consistent with the images' content.
- **1.4.1 Use of Color:** In some sections, color alone is used to convey information or distinguish elements without text or other indicators.
- **1.4.12 Text Spacing:** In some sections, line height, letter spacing, word spacing, and paragraph spacing may not allow for sufficient user customization without content loss or functionality issues.
- **1.4.13 Content on Hover or Focus**: Additional content triggered on hover or focus may not be dismissible, hoverable, or persistent as per specifications.
- **1.3.2 Meaningful Sequence:** Where the order of content affects meaning, this is sometimes visual only and not structured in code. Documents may also lack meaningful sequencing.
- **2.5.8 Target Size (Minimum)**: The size of some interactive targets (e.g., buttons or links) may not meet minimum size requirements, making them hard to activate for users with motor disabilities or imprecise touch inputs.
- **1.4.11 Non-text Contrast:** Essential components, including in various states, may not meet the required 3:1 contrast ratio against adjacent elements.
